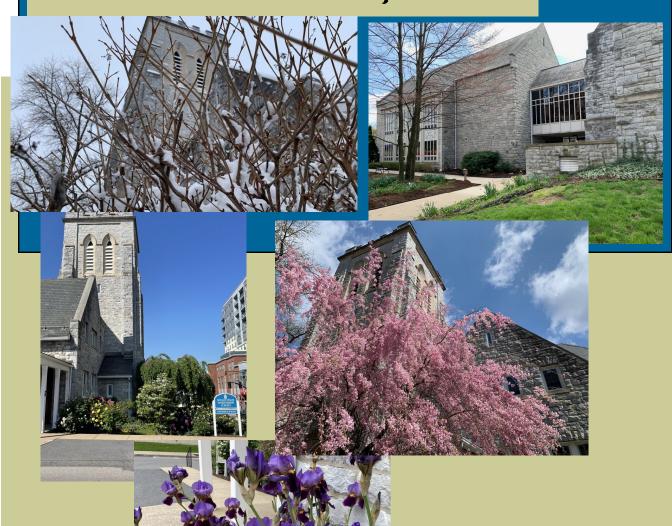

## STATE COLLEGE PRESBYTERIAN CHURCH CONGREGATIONAL MEETING January 29, 2023

The annual meeting of the congregation of the State College Presbyterian Church, as called by its session at its December 4, 2022 meeting, was convened in-person in the Sanctuary at 10:00 a.m. on January 29, 2023 by moderator Rev. John Porter. The meeting was announced from the pulpit and on the website on two preceding Sundays. The meeting was opened with prayer by Rev. Allison Maus. The clerk declared a quorum was present.

MINUTES: The minutes of the January 30, 2022 annual meeting, of the June 12, 2022 special meeting, the November 13, 2022 special meeting were **APPROVED** as distributed.

#### **REPORTS:**

<u>SOCIAL JUSTICE & MISSION TEAM</u> (Cricket Hunter)--Cricket reported the goals of SJ & MT in 2022 were to increase visibility of the Team and build connections and synergies. Serving together strengthens the fabric of community.

<u>YOUTH MINISTRIES</u> (Reed Dressler)--Reed reported on the activities of Youth Ministries, including cards for incarcerated and the Chrysalis Coffee House. Mission activities lead to an outpouring of creativity and growth. Youth activities give participants the opportunity to listen and be listened too. We have dedicated support for youth. He expressed gratitude for the establishment of a Youth Advisory Group, which will help grow the program and grow youth.

<u>COLLEGE-AGED & YOUNG ADULT MINISTRIES</u> (Allison Maus)--Allison reported that our CAYAM is nearly unique in its deep rooting in a congregation. The church connection gives CAYAM the opportuinity to create a space of peace and safety, as well as connections that challenge participants. The Young Professionals (YO-PROS) have added game nights, meals, reflection, mission and connections.

<u>FINANCIAL AFFAIRS</u> (Jason Stimmel and Bob Igo)--Jason reported on the 2023 budget approved by the session, which is printed on page 60 of the 2022 annual report. The budget adopted by session is balanced, but Jason pointed out budget challenges we will face in 2023 and beyond. Income peaked in 2015 and has slowly declined since then. Jason reported that Financial Affairs reviews the budget status weekly with our Financial Administrator Michelle Fortin. Bob Igo reported on our commitment to our program ministries Youth Ministry, College Ministry, Social Justice & Mission. We have met the challenges of the pandemic. Jason and Bob reported that Session has created a Stewardship Committee to focus on ways of tackling financial issues.

On behalf of the Financial Affairs Ministry Unit, Jason moved that the congregation receive the 2023 Budget approved by Session at its meeting of December 5, 2022. Motion was **APPROVED.** 

#### PERSONNEL (Cam Richardson)

<u>CHANGES IN PASTOR'S TERMS OF CALL</u>: Cam pointed out that Terms of Service for John Porter, as an interim pastor, were adopted by the session at its meeting of July 10, 2022 for twelve months. At this point, John Porter asked Allison Maus to leave the room during this discussion, which she did. On behalf of the Personnel Committee, Cam moved that the congregation approve the following terms of call for Associate Pastor Allison Maus for 2023. Cam noted that her participation in the Board of Pensions is governed by the terms of the Pathways to Renewal program of the Board of Pensions.

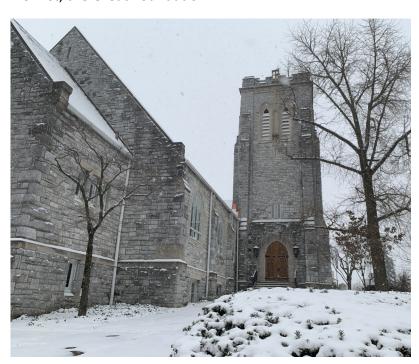

#### The Membership in 2023

Our 2023 Membership numbers show a loss of 139 for the year with the current congregational membership at 643 (gain of -127). We had 12 new adult members join the during our Sec-



ond Sunday Membership Opportunities. Normally, each year the rolls are reviewed and some names are moved from the active to the inactive roll. This year 124 members were contacted about their preferences regarding their membership (83 were adult children no longer living in the area). 93 were moved to the inactive roll, 13 were moved to the "Friend of the Church" List, and 18 requested that their membership be removed from our rolls.

### The 2023 Annual Report of The Session

The session of the State College Presbyterian Church is the council that leads and shapes the ministry of the church. It is composed of teaching elders (installed pastors) and ruling elders (members elected by the congregation

known as "the elders.") They are chosen by the congregation as persons of wisdom and maturity of faith, having demonstrated skills in leadership and compassion in spirit. In 2023, the session met on the third Sunday of the month following the Exploration Hour.

Significant events for Session in 2023 included discernment of our way forward in ministry, suggesting ways of most effectively using the gifts God has given us. We sent our youth on a mission trip again and a multi-generational group to volunteer at Hekima Place in Kenya. At home, we hosted Out of the Cold for two weeks, filled clean-up buckets for Church World Service, put innumerable presents under the Angel Tree and participated in Crop Walk and the Pride march. Our Spiritual Life Ministry Unit organized congregational retreats while Christian Education scheduled offerings for all ages every Sunday. We upgraded our security system for Stay & Play Preschool and offered inperson CAYAM (College Age and Young Adults) programming. As a new normal emerged, the Worship Ministry Unit was able to bring back elements of liturgy that had been truncated during the pandemic. The Building and Property Committee repaired our boiler and upgraded the parking lot entrance with a more practical and welcoming entry. The Financial Affairs Committee provided the information needed to make wise decisions about money.

Session went beyond restoration to innovation and discernment. A few of the highlights are listed here. Session started congregational fellowship lunches and Juniper Village block parties to enhance community ties. Session created a Generosity Committee to focus on encouraging members to share their gifts with the church. Session approved a Mission Discernment Profile to guide our Pastor Nominating Committee as it seeks a new senior pastor. With the retirement last spring of our longtime Director of Music Ministry Ned Wetherald, Personnel Committee brought us Tabitha Hansen as Interim Summer Organist, Austin Norrid as Interim Choir Director, and Aaron King as Interim LOGOS Worship Skills Coordinator. Olivia Mortimore filled in our tech needs for the summer before Michael McGillian was hired.

While ruling elders are elected by the congregation, normally for a three-year term, and may be reelected for a second term, they are ordained to the broader church for life. In 2023, our congregation's officers served on the Presbytery of Huntingdon Personnel Committee, Krislund Camp & Conference Committee, Permanent Judicial Commission, and Nominating Committee. Associate Pastor Allison Maus served as a commissioner to the Synod of the Trinity. Whether within the walls of State College Presbyterian Church, the Centre County community, or the broader church, elders offered their energy, imagination, and love through their ministry units and committees of the congregation. They assisted at the sacraments, received new members, and hosted the January 28 presbytery meeting.

The Board of Deacons, or Deacons, serves through witnessing, service and sympathy modeling after Jesus Christ. In 2023, the board included 26 members, 24 adult members and 2 youth members. Deacons are staffed by the Pastor and meet monthly except in July.

## The 2023 Annual Report of The Board of Deacons

A ministry of sympathy, witness and service after the example of Jesus Christ

The mission of the Board of Deacons is one of sympathy, witness, and service after the example of Jesus Christ. Our task is to serve the congregation and the surrounding community. The 2023 Board of Deacons consisted of 24 adult members and 2 youth members, with staff support being provided by Rev. John Porter.

The Deacons have two units to share the responsibility of caring for the church: Caregiving and Service. The Caregiving Unit provided meals for members of the congregation needing extra care, outreach to shut-ins during the holidays, and rides to church for members without transportation. The Service Unit organized fellowship events including the Palm Sunday breakfast, the Church Picnic at Tudek Park, the Pre-Advent Soup Supper, and Christmas Caroling. The Deacons also took turns delivering donated items to the State College Food Bank as well as providing ushering duties during Sunday morning worship and other services as requested.

2023 continued to be a year of transition and adaptation for Deacons as many activities returned to their pre-pandemic state. As a result, a sub-committee was formed to define the purpose and list of responsibilities for the Deacons as a whole. The purpose of each of the units within the Deacons was also clarified during this process. As we move into 2024, the Deacons will be able to use this information to provide additional outreach opportunities for the congregation whether they be through fellowship activities or providing additional support for members in need.

Under the direction of the Building & Property committee, a task force was formed to update the Emergency Evacuation Plan. Several Deacons served on this task force and trained the rest of the board on the new procedure, which is now in place.

From a financial standpoint, the Deacons provided monetary support for Church World Service Buckets project in the spring, the Crop Walk in the fall, as well as provided funding for various tasks and events sponsored by the group. Previous financial expenditures undertaken by the Deacons (such as requests from Centre Safe) have now shifted to other areas of the Church budget, but the Deacons are still able to provide financial support for those types of requests if needed.

In the coming year, the Deacons plan to be more focused on making their presence in the church more visible to the congregation. We look forward to serving you in 2024.

### The 2023 Annual Report of the Interim Pastor ~ the Rev. John Porter

Over the last twelve months the State College Presbyterian Church has continued to provide opportunities for education, spiritual enrichment, and worship to our members and to the community. We have maintained an active and significant ministry of community service and

compassionate care for those in need. All of this is due to the commitment and work of our elected Elders, Deacons, and volunteers. And it would not be possible without the leadership and support of our dedicated staff.

Along the way we have elected and commissioned a Pastor Nominating Committee to search for our next Senior Pastor, celebrated the retirement of a beloved Director of Music Ministry, and hired a new Director of Music Ministry who has just stepped into that position as of January 1, 2024. While we have seen a decrease in the number of regular contributors, contributions from continuing supporters has increased. I anticipate transitioning out of the Interim Senior Pastor position at some point in the coming year and I will be focused on preparing for that transition so that the next person in this office will have the opportunity to lead and guide this congregation in their own unique way. 2023 started to feel more like "normal", although concerns about respiratory illnesses still keep some folks away from

large group settings. It has been gratifying to know that some of the measures we put into place during the pandemic years to accommodate everyone still serve many of you today— online worship being paramount. Finding ways to stay connected remains goal number one for your staff. While most of our in-person programs have started back, many have come to depend on online worship, Zoom meetings, our creative emails, and churchwide texting to stay in the know. It has been challenging, but also gratifying to know that all of you have been responsive and supportive to everything we have tried to do.

#### **Managing Information and Communications**

Staying connected with communications continue to take up a large portion of my time. The Weekly Update email, program emails and managing the website are an important part of my work, and I continue to enjoy using those tools to keep all of you connected and informed (we have 1568 signed up to receive emails from our various lists). Our Weekly Update email list receives an email each Thursday with everything that's happening in the coming week as well as what will be happening in worship on the upcoming Sunday. We also continue to send an email on Saturdays with links to view our live-streamed worship service on Sundays. We are sending out other special program and meeting announcements as well as urgent prayer concerns as they come up, so if you're not on the email list you'll want to get signed up for it. I create, manage and publish the general email communications, so just send me an note (contact information for all staff are listed on the inside cover of

this publication) to provide your email address, or give a call to the church office (814-238-2422).

#### Zoom

Videoconferencing continues to be a necessity and I'm sure will be a mainstay in some form. Session and Deacons returned to in-person meetings but many small groups and committees continue to meet on Zoom. I am responsible for managing the church's zoom account and the zoom calendar - which can get a little crazy switching licenses around so everyone can meet when they need to, but it allows the groups and organizations to continue to meet and get their work accomplished.

#### **Worship Service Emails and Live-Streams**

While we have been worshiping in-person for a while now, the option of our live-streamed service for those who are physically unable to attend worship in-person as well as those who are continuing to be careful with their health remains very important and has become a permanent offering of worship. It is amazing to see the number of live-stream views the services get. We live-stream all of our worship services as well as some special services. Along with getting all the information out to you, I create and schedule the live-steams. The links to all the services are sent out by email and they are also available on our website and our (State College Presbyterian Church) YouTube channel.

#### Website

Certainly, managing the website and serving as website coordinator continue to be a huge part of my job and a fun outlet for me. My responsibilities continue to include managing, editing and writing content for the website, posting videos and sermons (as well as editing the sermons from the worship service recordings), making sure all of the Sunday Bulletins are there, and trying to keep it all current as my time allows - no small order!

You can go to our "Worship Service Live Streams" webpage to view the videos of our live-streamed services or view past recorded services on the archives pages. or the "Sermons" page (and archives pages) to listen to past sermons. You can also see the weekly Sunday bulletins on our "Worship Bulletins" page. The website is the go-to place for all the information about events, programs and everything that's happening here at SCPC.

#### **Church Texting Program**

We established our texting program so we would have a platform to notify you of important messages about building issues that might arise which may affect Sunday morning programs, as well as program announcements and reminders. This has evolved into one more way that we can keep in touch with online worshipers (you can "virtually" sign the friendship pad on Sunday mornings by texting "check in to our text number: 833-234-1326) and small group participants. You can also text in a prayer request that we will share in our Weekly Update prayer list and Sunday morning prayer concerns. While many staff members have access to the platform, I receive your Sunday morning "check-ins" and passing of the peace. We have 286 folks signed up to receive our occasional texts—If you're not signed up, let us know and we'll add your cell phone number to our database.

#### The PresbyPost Newsletter

When our long-time Director of Music Ministry and Newsletter Editor, Ned Wetherald, retired in May, it seemed a natural transition for me to take over publishing our monthly newsletter. You may have noticed a few updates but this long-time vehicle to keep you informed remains largely unchanged (hard to improve on an already great publication!). The PresbyPost goes out to 456 email addresses and 237 hard copies are mailed each month. We hope you are enjoying staying updated on all of the news!

#### **Membership Responsibilities**

While it certainly is the case that most of my time is devoted to communicating with all of you, I also am the staff resource to the Membership Ministry Unit. We are responsible for having opportunities for new folks to join our church family, among other activities. I monitor those who have signed the pew pads on Sunday mornings and reach out to those who are visiting the church as well as those who indicate they are interested in joining our church family. Our "Second Sunday" membership opportunity continues and we are looking into new ways of having information available to interested folks.

#### Other Responsibilities and Projects

Keeping the church database correct and current (keep those change of address notifications coming!), tracking LOGOS and FISH registrations, creating brochures, signs and posters, keeping the official records of the church, communicating with Session and preparing the church's annual statistical report as well as producing this Annual Report — all keep me busy throughout the year.

While we have enjoyed the comradery and leadership of Interim Pastor John Porter over the past year and a half, we know that 2024 will bring about more changes and transitions, and we thank you for your continued support. December 1, 2023 marked my 20 year anniversary as your Membership and Program Associate—it is incredible to me that 20 years have gone by and it is a blessing to be in ministry with all of you along with a talented and creative staff.

The job of the Mission Associate is to invite, support, and celebrate State College Presbyterian Church's work in

the world, primarily by serving as the staff resource person for the Social Justice and Mission Team, coordinating with staff, communicating with the congregation, and connecting with the wider community.

Historically, what was then called the Mission Team had come to focus on the extraordinary financial support by this church for work done to care for the world of State College and beyond. As part of the work that eventually defined this position, State College Presbyterian Church identified mission involvement and engagement as an area of growth, particularly as we emerged from our homes, and many of us re-entered shared physical spaces. The congregation had clarity that involvement and volunteering is important because it connects us to one another and it connects us more deeply to our geographic communities – people, places, and spaces – so that we can better live toward Beloved Community. This renewed focus on involvement in Mission is, of course, the reason that I am here.

Last year I spoke at the annual meeting about some of that engagement, including a few of the synergies I was seeing spark amongst the work and interests of a variety of groups, and after only a few months on the job. Thanks to an enormous variety of active groups in this church, as well as the Faith Formation staff workgroup, I continue to both seek and see opportunities to build on those synergies. While the richness of these collaborations cannot be captured by numbers, I want to share a few to give you a glimpse of just how much is happening here.

I want you to know that in 2023, I tracked 20 events and projects that had at least one foot firmly in Mission. Of these, 13 projects or events had intergenerational involvement, and there were mission

collaborations with 11 groups of State College Presbyterian Church.

These numbers count, to some degree, the financial contributions, time, creativity, and muscle contributed by this congregation, this year. What they cannot count is the *fuel for all of it: your prayers for this work, for this community, and for this world – for each beating heart, and each tender soul.* In addition to the projects we have completed together, the financial support this congregation provides to groups doing good work in State College, Centre County, and beyond continues to be important. I can tell you that those donations matter. We frequently receive calls for assistance from the community, and it makes an enormous difference that we can partner with healthy, effective agencies, where there are ongoing resources. This year we received calls regarding 52 people or households needing help. 27 contacted us themselves, 25 calls came from caseworkers inviting us to help with the missing pieces needed to get folks out of their immediate crises, like a burn patient who was able to receive care at CVIM, but could not afford the quantity of sterile dressings needed to continue the care at home.

Of those who contacted us directly, we connected 25 with other resources, and provided 17 with some amount of relief directly. Both the financial support for the agencies, and the \$500 quarterly that SJMT designated as the "compassion fund" this year, from which we can respond to these sorts of calls, means that some people whose lives are incredibly difficult can receive a variety of kinds of help.

State College Presbyterian Church, your Mission projects have been successful. They are connecting people across this congregation, and between our congregation, community and world. Each project also needs some amount of reinforcement or growth to be sustainable. Most need project descriptions, job descriptions, and road maps. It's a little boring, but, institutionally, we need to be sure that we can share the work of these projects as flexibly as life sometimes demands. This is work that I will continue in 2024.

How we do the work is as important as the work that we do. We need to make space for lots of different kinds of work, for many ways for people to help, so people feel they can join in, without sliding into overcommitment and burn out. I am mindful of the ways that people's lives change, and I hope the work to create project-focused teams that can allow seasonal involvement for some, and predictable, periodic involvement for others will allow many, many people to find their fit.

In all of this, I'm grateful to have the new 2023 Mission statement for SJMT to guide and focus us as

we move forward.

My job would not be possible without each member of our staff, without the dedicated members of the SJMT, nor without the many, many volunteers and great big warm hearts in this congregation. With all of that: it is a pleasure. Thank you.

#### THE ANNUAL REPORTS OF THE MINISTRY UNITS AND COMMITTEES

### The 2023 Annual Report of the Building & The Building and Property Com-Property Committee ~ Scott Sesler, chair mittee "shall be responsible for

the facilities and property of the

church, including the recommendation of policies, development of procedures, and oversight of staff relating to church facilities." In 2023, the B&P Committee carried out those responsibilities with a budget of \$125,000, the second largest committee budget after personnel. The budget included (in rounded numbers) \$15,000 for electric costs, \$4,700 for water, sewer, and trash costs, \$21,000 for natural gas, \$5,000 for janitorial supplies, \$6,700 for property taxes, \$5,000 for snow removal, \$13,000 for maintenance contracts, and \$54,600 for building maintenance and repairs. Of the \$125,000, \$122,157 was expended, a savings of \$2,843 or under budget 2.27%. Members of the committee in 2023 included: Scott Banfield, Glen Blume, Carolyn Bryant, Dale Cox, John DiNunzio, Don Hartzell, Todd Hockenberry, Clark Moose, Pete Moyer, Pastor John Porter, Scott Sesler, Laura Seeley, Laura Steager and Tom Wheeler.

#### The committee's work in 2023 included:

- Dealt with extensive problems with the church's heating plant including major repairs to the boiler and other components, expending close to \$41,000 during 2023. The Committee continues to closely monitor the boiler's operation and projected lifespan.
- Addressed problems with the kitchen's ice making machine. And after a number of attempts, the problem was finally determined and correctly repaired.
- With repairs to the hot water heating system and the ice maker, the Committee was able to bring water consumption back down into the range of normal, average usage. Unfortunately, we still exceeded the budget for water for the year because of the leaks.
- Per Session's request of all committees, the Committee's description was updated.
- Had the lawn west of the tower walk repaired and upgraded and replaced a tree.
- Having on-going discussions regarding safety upgrades to the building's entry points.
- Installed a new door station at the ground floor entrance to the Stay & Play Preschool in the parking lot stairwell. This station provides for remote unlocking of the door and a camera for identification purposes.
- Investigated the operation of the water softener after receiving reports of fluctuating water hardness. After numerous inspections and some minor adjustments and repairs, it was determined to be operating correctly.
- There was some damage to the chancel's wood flooring during the Arts Festival by some of the performers. We solicited a number of bids to repair it, proceeded to have the floor repaired, and was reimbursed for those repairs (\$1,400) by the Arts Festival.
- The policy for use of the building was reviewed, updated, and adopted following the above incident. The revised forms and policy were then initially used for First Night State College.
- Warranty work was completed on the stained glass windows (with the exception of one) at no cost to the church, resolving a problem with paint adhesion due to use of the incorrect caulking.
- It was determined that the exterior entry door at the lower bridge level did not have an operational door entry alarm on it. An alarm was subsequently installed.
- There were two, original china water fountains on the ground floor that were deemed unrepairable and problematic. Consequently, both were permanently removed.
- A new, permanent, covered entryway was constructed at the parking lot entrance to replace a

smaller, tired, canvas awning. The new structure better defines the entrance, blends well with the existing structure, provides shelter from the weather, and provides lighting for the entry and the parking lot. Funds for the new \$29,500 entryway came from the capital reserves of the Restoring God's House Fund and private donations.

- We finally received a favorable water chemistry report in December on the boiler. After many
  interruptions to the water flow due to repairs and evaluation of the many treatment components
  to ensure that they were operating correctly, we were able to get the treatment chemicals back
  to favorable levels, thus improving the longevity and efficiency of the boiler.
- The committee requested that the Finance Committee establish a B&P "Preservation Fund" to
  accept gifts for the purpose of preserving and improving the buildings of the church. B&P would
  control expenditures and funds would remain available across budget years. The request was approved.
- Both R.H. Marcon, Inc. and The Durable Slate Co. completed roof inspections late in 2023. The committee will review both reports in 2024 and act accordingly on them.
- The Committee approved the fabrication of a new SCPC sign to match the existing ones and to be installed on the new parking lot entry structure. Installation scheduled for early 2024.
- The Committee also oversees, on a continuing basis, many maintenance contracts including ones for: pest control, elevator maintenance and inspections, fire sprinkler system, security system, door access control system, boiler water treatment, fire extinguishers, kitchen hood fire suppression system, roof inspection, and air conditioning condenser maintenance.

**SMART: SCPC Maintenance and Repair Team** - is a group of volunteers that meet monthly for three hours to work on keeping the church and grounds looking their best. Tasks included painting, repairs, gardening, and trimming. Thank you to the following for their work in 2023: Glen Blume, Jane Butler, Dale Cox, John DiNunzio, Todd Hockenberry, Bob Johnson, Judy Killam, Ken and Sharon Manno, Scott Sesler, Denny Shanafelt, and Margaret VanFossan. The team is headed and organized by Don Hartzell. Please call Don if you would like to join and help this group of volunteers. Together they were able to accomplish the following:

- Cleaned approximately 100 chairs in Westminster Hall and the Social Hall.
- Polyurethaned the top of the choir loft modesty rail and touched-up the stain on same.
- Touched-up scratches and gouges in the Sanctuary wood floor and on the pews.
- Painted some of the baseboard and touched-up the walls in the Social Hall.
- Repaired and painted damage from a roof leak in Deannine's office ceiling.
- Touched-up the chair rail and baseboard; and repaired drywall in Westminster Hall.
- Trimmed all of the bushes and hedges (twice) on the church grounds.
- Weeded the Church's gardens and flower beds.
- Replaced a number of stained carpet tiles in the ground floor hallway.
- Touched-up the wood trim and walls in the newest education wing.
- Tended to the landscaping in the Columbarium on a monthly basis.
- · Repainted one of the exterior benches.

Our thanks to our Building Manager, Todd Hockenberry who works very hard at keeping our church and grounds in tip top shape! Todd is a great steward of the building along with his daughter Chelsea. The two of them keep our facilities clean and in good repair. We sincerely thank them for all of their efforts!

Here is a glimpse into our work toward living out our mission just a couple of blocks from Penn State's University Park campus and how this congregation is working to make our church a home for our young people.

Through it all, wholeness and wellness has been a priority and each member of the Chrysalis community has done their part to make our time together the best it could be.

The year brought us some unique experiences that we'll remember for a long time to come. We put on our yearly Coffee House and Lock-in at the end of January; we had a blast sharing our talents in many ways, as well as enjoying time locked in at the church together. We had a picnic and took a walk in the woods together. We also went downtown and on campus for our annual scavenger hunt, taking pictures and interacting with members of the community. The Financial Affairs Committee, under the direction of Session, is responsible for the financial affairs of

the church. Members of the Finance Committee review and monitor the accounting of all monies received and dispersed by the church, handle investments, prepare goal and operating budgets and maintain adequate insurance. The committee also provides recommendations on financial policies and is also responsible for protecting all legal documents, corporate papers, contracts, and other effects of legal worth. These activities are handled at our monthly meetings and through weekly payment approval sessions with the financial administrator.

In 2023, the members of the Finance Committee were: Elders Carolyn Bryant, Bob Igo, Meg Moose and Jason Stimmel (Treasurer and Chair); and Deacon Scott Banfield. We would also like to acknowledge our pastoral staff for their leadership and support, and give a resounding THANK YOU to our Financial Administrator Michelle Fortin, and Assistant Financial Administrator Anne Thomas, for their diligence and hard work on behalf of the church.

Each year, the Finance Committee works to develop a balanced budget that seeks to accommodate projected (and requested) expenses provided by the individual Ministry Units and match those requests with the overall projected annual income for the church (including individual pledged giving). For the past three years this task has become increasingly more challenging as our church has seen significant changes in personnel and membership. This issue was brought to the congregation's attention in January 2023 when pledged giving fell below projections, resulting in estimated net income versus expenses showing a year-end deficit. Through your generosity giving increased over 2% from what was budgeted, however FYE23 will still end in deficit spending. There remains much

work to be done to find a sustainable budget that supports our church staff, our programs, and our mission going forward.

For reference, the approved budget for 2023 was \$1.004M which included an approximately 10% increase in personnel and 17% increase for building and property. Actual pledged giving income was \$658K (\$775K was planned), with projected net income adjusted to \$887K and the call to the congregation to target \$825K in giving while session would work to reduce expenses where possible. For FYE23, the majority of the shortfall was covered through approved utilization of endowment and restricted funds. We will end the year with an approximately \$30K deficit that will be covered by transferring funds from the Operating Reserve.

Our church continues to be blessed with a financial foundation built on our endowments, designated funds and memorial funds that represent the incredible generosity of our church family. Combined, these funds have helped pay for many of our church programs that otherwise could not be supported by annual giving income only. Finance has worked diligently to find ways to strengthen and grow these funds with the understanding that in the years ahead they will become critical to ensuring the church has a sustainable operating budget which continues to support our staff, the maintenance needs of our building, our many programs, and our mission.

Looking ahead into 2024, there are many major changes coming for our church: a new Director of Music Ministry starts, the pending hire of a new Senior Pastor, the renewing of our call for an Associate Pastor, and continued increases in expenses to maintain our church building. These financial challenges face the growing headwinds generated by societal changes that all denominations of faith are encountering: the struggle to grow and attract new members and their engagement with the church. Within our own church we are witness to these changes, which have greatly impacted how we budget and financially plan.

With these factors in mind, session approved the proposed budget for 2024 to show total annual income and expenses of \$1.06M, which represents an approximate increase of 6% mostly attributed to rising personnel costs. The budget includes the goal for net giving to reach \$825K (approximately \$699K of which has been pledged). Additional income to balance the deficit budget will come from use of available endowment funds and drawing down of the operating reserve. This deficit budget is proposed by session with the understanding that significant changes will be necessary and required beyond 2024 owing that the operating reserve is projected to be depleted by the end of FYE 2024.

We are grateful for all our blessings and the congregation's continued financial support. In the coming years with the changes and challenges we face, Finance will be working diligently with Session to find a sustainable budget that balances the use of available funds from our endowments, designated funds and net giving with projected expenses that are appropriate, and which can be supported by our congregation.

As this year comes of a close, I reflect on the past six years that I have been Treasurer at how much has changed within our church and the many challenges that we have faced as a congregation. I have been amazed at the generosity and commitment to our church and congregation by this family. Together we have faced these challenges and have always overcome them. I know that same perseverance and spirit will continue as my time as Treasurer ends. We are all in good hands as Meg Moose will now be at the helm of our financial ship as the new Treasurer and will steer us well through the challenges that lay ahead.

The Membership Ministry Unit has the responsibility of maintaining accurate membership rolls. To establish our annual

assessment to the Huntingdon Presbytery, rolls are reviewed annually. Our 2023 assessment was \$39.24 per active member but our responsibility to Presbytery was based on the 2020 year-end membership number of ? (per Presbytery). The actual 2023 year-end membership was 643.

Martha Trout maintains contact information on all visitors and communicates with them about the opportunity to join our church family. New members are introduced to the congregation at the earliest opportunity. During 2023 we welcomed 12 adult members into SCPC membership. Our committee functions include scheduling Second Sunday membership opportunities where one of our pastors and two elders meet with prospective members to join the church or to ask questions and learn about the church. We also schedule greeters for Sunday service and other special events and elders for the Information Desk. This year we also began scheduling to update the pictorial directory with several opportunities for members to get their photo taken after church by several volunteer photographers as well as Juniper Village and other off-site locations. The Membership Ministry Unit is responsible for correspondence to visitors considering membership and we monitor visitors via the pew pads each Sunday. **Leicht, Laura Millard, Jerry Sawyer, Katie Stone, and Steve Van Hook** to the Pastor Nominating Committee (PNC) to bring a new pastor to State College Presbyterian Church (SCPC).

The committee first met on April 10<sup>th</sup> led by Pastor John Porter. Pastors Ken Raney (from Pine Grove Mills), and Terry Musser (from Milesburg), of the Huntingdon Presbytery Committee on Ministry (COM) were added to the committee to provide process guidance and support. At that meeting, the committee appointed Bob Igo as chair and Jamie Bauman as vice chair and Rob Leicht as secretary. Pastor John led the committee through the mechanics and purpose of the group. He explained that the PNC would have the Pastor Visioning Team Report, Session and other key resources to develop the Ministry Information Form (MIF). The MIF will be entered into the Presbyterian Church's "Church Leadership Connection" (CLC) database to match with candidate's Pastor Information Forms (PIF) that were submitted to the CLC. The committee will receive PIFs that align with the SCPC's MIF. At the time, the CLC was undergoing a system overhaul. Forms were renamed to MDPs and PDPs re-

At the time, the CLC was undergoing a system overhaul. Forms were renamed to MDPs and PDPs respectively. The database changes provided greater functionality and evaluation capability. This change delayed the PNC in its discernment process by approximately one to two months.

At the April 10<sup>th</sup> meeting, PNC established meeting guidelines, disciplines, and processes, and to meet weekly beginning April 19<sup>th</sup>. The group determined that a quorum of the committee would be four of the seven committee members and candidate decisions would be based on a five-member majority vote. Meetings would be held at the church with a Zoom option. They also agreed to provide the congregation with monthly updates during a worship service, through the PresbyPost, and to Session.

Since forming, PNC has met nearly every week, providing the monthly updates to the congregation and Session as intended. The committee started receiving and reviewing PDPs from candidates who were aware of our search (self-referred) in late May and June. The bulk of PDPs started arriving in August. Since then, PNC received over 80 PDPs for review. They reviewed the submissions and requested additional information from 15 pastors. Four of those candidates opted not to go further with our church. Of the remaining pastors, PNC held first round interviews with five of the candidates and moved to a second round with several remaining pastors.

Currently, we are conducting a third round of interviews designed to show the best fit for our congregation. Pending the results of these interviews, the committee will conduct reference checks, submit the name of a candidate to COM for an interview, and begin the terms of call process. Once both parties have agreed on the terms of call, PNC will inform the Session and request a congregational meeting to present the candidate for the new State College Presbyterian Church Head of Staff.

Finally, the Pastor Visioning Team identified four critical leadership requirements: Theological/Spiritual Interpreter, Communication, Organizational Leadership, and Interpersonal Engagement. The members of the Pastor Nominating Committee have and are working diligently in a collegial and Spirit led effort to discern and bring to our church the leader as envisioned by the Pastor Visioning Team.

The Personnel Committee is responsible for matters pertaining to the compensation, benefits, care and welfare of the staff. We also work with members of other Committees to fill staff vacancies.

2023 has been a busy year of transition, as our

church PNC continues the search for a new Senior Pastor/Head of Staff, while benefitting from the leadership of Pastor John Porter to guide us and keep the ministries of SCPC moving forward. SCPC also celebrated the longtime service of Ned Wetherald, our Director of Music Ministries who retired at the end of May 2023.

Specific efforts in 2023 include:

- Working with the Pastoral Search Visioning Team to create a Position Description and Compensation Range.
- Celebrating Ned Wetherald's retirement with a congregational reception, and a staff luncheon so Ned's colleagues could gather and wish him well.
- Celebrating Deannine Shipman's 25<sup>th</sup> anniversary at SCPC in April 2023 (Her actual anniversary was in November 2022)
- Shepherding the extension of John W. Porter's Terms of Service and Housing Arrangements for an additional period of 12 months with our enthusiastic thanks
- Implementation of a 2.5% COLA increase for staff in June 2023, retroactive to January 1, 2023. This increase was in the 2023 budget.
- Elder Dick Bundy agreed to lead a Search Committee for a new Director of Music Ministry, along with Elder Laura Robinson. The committee's search was completed on January 3, with the hiring of Heike Burghardt Rice. We thank the team for their expertise and time commitment in this effort.
- Personnel Committee also worked with the Worship Committee to secure Interim Music staffing between Ned's departure and Heike's arrival. Our thanks are extended to Tabitha Hanson, who provided organist duties during the summer; Austin Norrid who served as Interim Director of Choir and Bells; and Aaron King who worked with LOGOS through the fall. In addition, we welcomed Dr. Anthony Leach who provided organ and piano coverage during the interim and Jose Mijanos who played on New Years Eve Sunday.
- Michael McGillian joined the part-time staff as Technology Coordinator in September, and we thank Olivia Mortimore and Dieter Van Hook for their service as fill-ins this year.
- Michelle Fortin met online with a representative from PCUSA Benefits/Medical/Pension Board in September to review benefit options for consideration.

ly or socially disadvantaged locally, nationally and internationally. Our goal is 100% participation across the congregation in at least one mission related activity each year: in deed, financial support or prayer. We strive to offer intergenerational events so families have the opportunity to participate together.

In 2023 SJMT revised our mission statement to more accurately reflect our goals and ideals. The committee is also beginning to think about a project based approach to activities and events.

Local support in 2023 included ARC of Centre County, Bridge of Hope, Centre Helps, Centre Safe, Centre Volunteers in Medicine (CVIM), Housing Transitions, Interfaith Human Services, Out of the Cold (OOTC), Park Forest Day Nursery, SC Area Food Bank and the Youth Service Bureau. Funds were disbursed to these agencies during Centre Gives, to maximize the benefit of our giving, and at the end of the calendar year. Additionally, we assisted with unexpected needs such as short term rent assistance, bus tickets and first aid supplies.

Our non-local support included financial support for Hekima Place in Kenya,

Presbyterian Disaster Relief and a contribution to the Haitian American Friendship Fund.

We continued with 9:00 am Sunday

worship services during the program year, switching to 10:00 am for the summer. Although attendance for worship and other Sunday morning activities remains positive, there remains concern about the 9:00 am time. A four-person group has been formed to work with a social scientist to survey the congregation about their needs and preferences. We hope for information from this to make further decisions about service times in conjunction with the coming of a permanent pastor.

We continued to use the hybrid form of communion we started last year. We celebrate communion the first Sunday of the month from January through Lent and switch to the last Sunday of the month through August skipping September and back to the first Sunday of the month to celebrate World Wide Communion Sunday.

Passing of the Peace was added after the Prayer of Confession during worship. The congregation seems to enjoy and participate (lots of smiles and chatter). The Apostles' Creed language has been updated.

Much of the unit's focus was providing continuity to our music program with Ned Wetherald's retirement as Director of Music Ministry, after 30 years, in May. We are so grateful to have had him, but his departure left a big hole. We were fortunate to secure musicians as organist and pianist over the summer and fall - Tony Leach, Jonah Glunt, Heike Burghart Rice, Tabitha Hanson and Jose Mijangos. In September Austin Norrid was hired as Interim Choir Director which enabled us to have chancel and bell choirs' participation in worship, and the traditional Candlelight, Advent and Christmas Eve services. Transition continues, but in the midst of change, and sometimes tumult, we are thankful for our creative and thoughtful ministerial staff - John Porter, Allison Maus, and directors Deannine Shipman and Reed Dressler. The Advent theme was attentiveness focusing on the senses of taste, touch, sound and smell (one sense each Advent Sunday). Invitation to Attentiveness and guided reflection began the worship services. During the offering congregants were encouraged to take an active part and write out thoughts, prayers, concerns and place them in the offering plates. Lovely painted banners, doors and sanctuary hung with wreaths, poinsettias and the Advent wreath helped make the celebrations special.

A grateful thanks to so many of you who make our worship meaningful – our church staff and ministers, pulpit fills, liturgists, instrumentalists, choirs, and LOGOS.

# The 2023 Annual Report of Stay and Play Preschool ~ Laura Seeley, Director



**Our Mission Statement:** Stay and Play provides a preschool and childcare program where both

children and adults feel loved, supported and empowered in an environment of compassion, respect and trust. Each child at Stay and Play is treated as a unique creation and is nurtured in his/her diversity and individuality.

Compassion, respect and trust continue to be instrumental to our ability in continuing to operate during and after this pandemic. The pandemic continues to affect our program in many ways. However, the staff have been truly amazing at fulfilling their roles as compassionate, respectful and trusting teachers.

Stay and Play is a part-time program licensed by the Dept. of Human Services, for 35 years offering affordable quality childcare and preschool programs to families of our community. Each year the good reputation of the program continues to bring new students/families via word of mouth. As a part-time program, we are open September – May. Our school year enrollment was just over 80% for the first half of the 2023-2024 school year.

We are back to our normal 9:00 am-12:00 pm time schedule this school year! Each morning class is still 3 hours long:

Darling Deer (1 year olds): 9am -12pm Terrific Turtles (2 year olds): 9am-12pm Wonderful Wolves (3 year olds): 9am-12pm Fabulous Foxes (4 year olds): 9am-12pm

Rainbow Raccoons (3 & 4 year olds): 9am-12pm

The afternoon class from 12:00-2:45pm for 3 & 4 year-olds called Adventure Afternoons has been well attended. This class is an option for parents to extend their child's day if they wish. Many families choose a day or 2 a week for their child and some choose every day to extend their child's day. This option/class has been very well used by families this school year. We did not offer Early Morning Drop-Off again this school year. Summer Camps were also not offered this past summer.

Tuition rates are reviewed annually to ensure we are able to sustain the high quality of care we currently provide as well as remaining financially comparable to other childcare providers in this community. Tuition rates will increase for the next school year as seen below. We continue to be one of the most reasonably priced programs in the area.

We continue to participate in Childcare Information Services (CCIS) program which offers financial assistance to parents/families who are accepted in the CCIS tuition assistance program. We also continue to provide tuition assistance ourselves to those with a need for financial assistance but do not qualify for the counties CCIS program. Maintaining confidentiality for these families continues to be essential. We continue to offer a staff benefit of 50% off tuition for staff children to attend S&P — we currently have 7 children covered under this benefit.

Michelle Fortin, SCPC's Financial Administrator, has again been extremely helpful in assisting with all adaptations, applications and verifications of grants, monthly finances, etc. Use of the ACH Debit program for tuition payments has increased this year to 85% participation. It's been very beneficial.

Block Play, Math games, science experiments, lots of reading books, phonemic awareness work/play, some number and letter recognition, puzzles, floor games, table games, weighing things, measuring things, patterns, matching, all types of concepts (big/small, heavy/light, magnetism, buoyancy, etc.), dress up imaginary play, painting, gluing, folding, cutting, creating art, writing practice, playing with manipulatives to build and learn, working together to build, solve problems, indoor playground play &/or outside park play, music class, music in our classrooms, recycling, composting, celebrating holidays and birthdays, and so much more. All while having fun!

We have been able to continue offering the option for Speech (or other) therapists to come to the program to meet with students they work with. They always have the option to stay in the class-

room with the child, or we are offer another room for them to meet 1:1 with the student(s).

Throughout the spring/end of the last school year and into the Fall/beginning of this school year, the teachers have worked so very hard to find ways to share the children's Stay and Play school experience with their parents and reintroduce families back into our program during classroom hours. We have allowed parent volunteers once again into our classrooms! This December our Wonderful Wolves (3 year-olds) acted out the Nativity story as their teacher, Miss Valerie narrated. Parents and families were overjoyed to attend in Westminster Hall. We also did a short Halloween parade outside for parents and hope to do more activities like this to bring the children's experience into the forefront for their parents. Stay & Play also hosted our second annual Snacks with Santa! Our families were invited to visit with the jolly man himself, and have a snack and color with friends! We had a great turn out of our families, and some very generous and appreciated donations. Music Observation was also possible in early December, and our families really enjoyed participating in music class in Westminster Hall! The Rainbow Raccoons had a display of some artwork at Schlow Library in the Children's department in December 2023. What a great experience to showcase their work!

# The 2023 Annual Report for Scout Troop 32 ~

# Nate Metzel, Troop 32 Boys Scoutmaster Allen Haar, Troup 32 Girls Scoutmaster

Boy Scouts of America program in 1914, four years after the national organization was founded. Troop 32 has been continuously chartered by the Church since then for 109 consecutive years, making it one of the longest continuously chartered troops in the United States, and the longest in Centre County, Pennsylvania.

Troop 32 had 17 boys and seven girls ranging in ages from 11 to 17 active in the Scouting program in 2023. The Troop is youth-led, with advice and counsel provided by volunteer adult leaders, with 13 adults actively serving as Scoutmasters, and eight adults participating as committee members in 2023.

The Troop participated in 12 camping activities during the 2023 calendar year totaling 368 total nights camped by Scouts and adults. Typically, the Troop holds one weekend of camping each month of the school year. The Venture Patrol, Scouts between the ages of 13 and 17 who have demonstrated the skills and knowledge required to achieve the rank of First Class, holds additional, more physically demanding activities that might not be suitable for younger, less advanced Scouts.

The longest outings for the troop as a whole were two five-night summer camp opportunities at Seven Mountains Scout Camp in July. The highlight of the year for the Venture Patrol was their high adventure trip to the Monongahela Forest in West Virginia for a five-night backpacking trip.

The Troop's scouting program included a variety of activities: Scouts and adults backpacked/hiked 570.5 total miles, biked 169 total miles, and paddled 32 total miles.

The Troop's service to the community in 2023 included 10 different service projects, with a majority of the Scouts and adults participating in more than one project. Service projects included workdays to help Scouts complete their Eagle Scout projects as well as community service projects to support Foxdale Village, Seven Mountains Scout Camp and the State College Food Bank. In total, the Troop accumulated 338 community service hours in 2022. While the Scouts adhere to the Scout slogan "Do a good turn daily", these larger community service projects help all who participate and practice servant leadership.

The Troop is proud of the outdoor skills, knowledge and achievements demonstrated by its Scouts. In 2023, Scouts earned 21 rank advancements in Troop 32. There is a plaque hanging in the hallway outside the sanctuary that bears the names of those Scouts from Troop 32 who have earned Scouting's highest honor, the rank of Eagle. Allison Cole achieved Eagle in 2023, becoming the first female Scout in Troop 32 history to earn this rank. In addition, four earned Star, five earned First Class, three earned Second Class, four earned Tenderfoot, and two advanced to Scout. Scouts also earned 84 merit badges and five outdoor awards in 2023.

The Troop is blessed with outstanding volunteer adult leadership. These adults devote a great deal of time and effort to providing the Scouts with an outstanding and varied array of programs. Each Scoutmaster and Committee Member has completed youth protection courses and gone through Commonwealth mandated background checks and courses to ensure the safety of the Scouts. Additionally, a majority of these volunteers have given additional time and resources to complete position-specific training offered by the Scouts BSA.

# The 2023 Annual Report of the Internal Audit Committee

Date: June 8, 2023

To: State College Presbyterian Church Session and Membership

From: Internal Audit Committee (IAC)

Re: Inspection of the 2022 State College Presbyterian Church Financial Records

The Internal Audit Committee (IAC) inspected the calendar year 2022 financial records and reports of the State College Presbyterian Church of State College, PA (SCPC) and is pleased to submit this report of our findings. While our inspection was limited to testing the transactions and balances and would not necessarily disclose all errors, we found no evidence of significant errors or omissions. In our opinion, the SCPC financial reports are fairly stated.

Our inspection of the SCPC financial records followed the procedures outlined in the SCPC Audit Committee Procedures Handbook, as revised March 2023 (Handbook). Our inspections were conducted in-person. As noted in the Handbook, our inspections are not a complete audit of the SCPC financial position and are not guaranteed to be accurate. In issuing this report, we note that our inspections were not conducted in accordance with Statements on Standards for Accounting, Auditing and Review Services issued by the American Institute of Certified Public Accountants or performed in accordance with those prescribed by the Auditing Standards Board. Furthermore, this report is the committee's general opinion on the fairness of the SCPC financial records and reports, which may not necessarily be in accordance with Generally Accepted Accounting Principles (GAAP).

While the committee found no significant sources of concern, we wish to bring the following items to the attention of Session and the Financial Affairs Committee (FAC):

### INTERNAL CONTROL, PRACTICES & PROCEDURES

- 1. IAC notes that SCPC does not have an updated inventory of non-cash assets (item #6 under "Internal Control, Practices & Procedures"). However, IAC acknowledges that a video record of SCPC was recently created (May 2023), which should meet the same needs as maintaining a list of property. Since an annual list of church property is not maintained, we are unable to certify item #1 under "Property, Insurance, & Miscellaneous Testing". IAC recommends that FAC consider revising the Handbook to match with SCPC practice in maintaining a list of property and that FAC ensure that a video record is made each year.
- 2. The phrase "investment related earning allocation" in item # 11 under "Cash Receipts & Balances Testing" is unclear. IAC recommends that FAC revise this item to clarify what is meant and what should be audited.
- 3. IAC notes that it is not possible to implement item #13 under "Cash Receipts & Balances Testing". It is also unclear what IAC should do with the year-end statements if they were available. Thus, IAC recommends that FAC revise the Handbook to either clarify item #13 or remove it.
- 4. IAC observed the offering collection on Sunday, April 30, 2023, and found no significant issues of concern. Since the committee was constituted in January, we were unable to observe a collection in 2022 the year covered by this audit. IAC does recommend that SCPC make a simple handheld calculator available for the Deacons doing the counting.

5. IAC notes that in several places the Handbook requests that IAC review the insurance coverages to determine their adequacy. Determining the appropriate amount of insurance coverage for SCPC is beyond our expertise. Thus, IAC recommends that FAC contact an outside insurance expert to verify that the insurance coverage amounts are appropriate and that all groups affiliated with SCPC (e.g. Scout Troup 32, Out of the Cold, Stay&Play and FISH) are covered. IAC was able to determine that all insurance policies are up-to-date.

- 6. For item #15 under "Cash Disbursement Testing", IAC notes that it was unable to verify/audit the accounts for Scout Troup 32 as they were not part of SCPC in 2022. Also, IAC was unable to verify/audit the Deacons' accounts as they are maintained separately from the finance office.
- 7. For item #16, IAC notes that FAC is actively drafting a "disbursement record retention policy". Thus, IAC was unable to review this item for 2022. IAC does note that the Financial Administrator is keeping financial records for seven-years, which seems appropriate.
- 8. IAC notes that the financial records of SCPC are housed on the same wireless computer network used throughout the church. While the SCPC financial and business records are maintained on a separate password protected section of the network, IAC notes the potential for these files to be compromised by a hacker via access from the guest account side of the wireless network. The members of IAC are not internet or computer security experts. Thus, we recommend that FAC investigate or monitor the security of the financial records on the SCPC wireless network.

We wish to commend Jason Stimmel (Treasurer), Michelle Fortin (Financial Administrator), Anne Thomas (Assistant Financial Officer), and the members of the Financial Affairs Committee for their fine work during the year. On behalf of the congregation, we thank them for the gift of their time and talent.

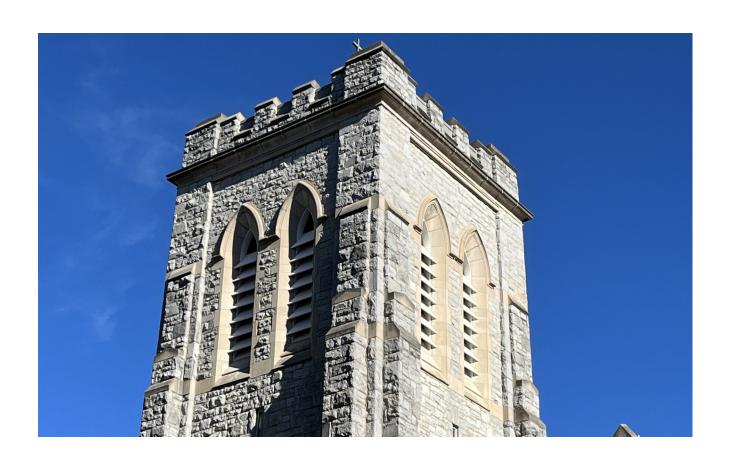
